

AGCAB Privacy Policy

AGCAB and its franchisees, subsidiaries and other related corporate bodies recognise the importance of protecting your privacy when dealing with your personal information pursuant to the Privacy Act 1988 (Cth).

About this Policy

This policy sets out how agcab.com (AGCAB) collects, uses and discloses your personal information. If you disclose personal information to third parties this policy will not apply and you will be subject to the privacy policy of that third party. By accessing or using AGCAB services, you agree to the use and disclosure of your personal information in the manner described in this policy.

What personal information is collected ?

AGCAB collects personal information that it considers necessary for it to provide the range of services offered.

Personal information collected by AGCAB may include:

- Your name, address, email and contact details.

How is personal information collected ?

AGCAB collects personal information in a number of ways, including:

- directly from you when you provide information directly to AGCAB in person, by phone or in writing (whether electronic or otherwise)

How is personal information used ?

Your personal Information may used for the following purposes:

- to provide the services requested by you;
- to manage those services including, customer service and billing;
- to research, develop and improve AGCAB services;
- to conduct surveys to determine use and satisfaction with AGCAB services;
- to promote and market special offers and other services to you. You will have the option to opt out of this service if you wish; and
- to personalise the advertising you see when you visit sites within the AGCAB network.

How is personal information disclosed ?

AGCAB may disclose personal information to individuals and organisations other than AGCAB. The organisations to which we may disclose personal information include:

- individuals and organisations that advertise with AGCAB if you submit an enquiry with AGCAB

What if you don't provide personal information ?

If you choose not to provide personal information when requested, AGCAB may not be able to provide you with the full range of AGCAB services. False information provided will also not be able to benefit from our full range of services.

The AGCAB Network, Linked Sites and personal information

When you visit a website or use an application on the a AGCAB Network, AGCAB records anonymous information such as IP address, pages accessed and documents downloaded, type of browser and operating system.

AGCAB also uses “cookies” which are pieces of data that may be sent to the browser on your computer's hard drive to enable us to provide you with certain features and provide us with information regarding website visits. Most browsers automatically accept cookies but you do have the option to decline. If cookies are disabled AGCAB may not be able to provide you with the full range of AGCAB services.

The AGCAB Network includes links to third party web sites applications and advertising served to the AGCAB Network by third parties (Linked Sites). Companies who operate Linked Sites may collect personal information through the use of cookies and otherwise. AGCAB is not responsible for Linked Sites and recommends you read the privacy policy of Linked Sites before disclosing your personal information.
